AMB. MATTHEW WILSON is the Ambassador and Permanent Representative of Barbados to the United Nations and Other International Organizations in Geneva. He has held various senior roles in international organizations, including Chief of Special Projects/Partnerships and Chief of Staff at the United Nations International Trade Centre and Senior Adviser and Counsellor to the Director General and Deputy Aid-for-Trade Coordinator at the World Trade Organization (WTO). Previously, he was a career foreign service officer. He has postgraduate degrees in International Relations, Development Studies, and an MBA Essentials. He has a Bachelor of Science (BSc) in psychology and sociology. He is on the board of the International Gender Champions and is currently Chairing the WTO Small Businesses Working Group.
